



COVID-19 Pandemic Protocol – M.I.A.D.F. Consent Form

The studio will be implementing the following strict protocol for our dancers, families and staff. Please sign and return the consent form for each Staff Member/Dancer.

Arrival/Departure

1. Studio Staff Members must arrive at least 15 minutes before the start of their class.
2. Upon arrival to studio, please observe social distancing guidelines as you approach the entrance. If there are more than 8 people waiting to be checked in, please be considerate of the time required to check in and return when line is less crowded. Spaces will be marked to enter and exit the studio meeting social distancing guidelines.
*Staff Members will be allowed to enter as soon as they arrive to prepare for class.
3. All parents may drop off their child but will NOT be allowed to wait inside of the studio.
4. All Staff Members/Dancers will have their temperature taken at the door before entering the studio. If a Staff Member/Dancer has a temperature at or above the [CDC Guideline](#) of 100.4° F (38° C), the Staff Member/Dancer will be kindly asked to return after 14 days. They may return after 5 minutes to have it re-taken. Should it still remain at or above the CDC Guideline, they will kindly be asked to return after 14 days.
5. If Staff Member/Dancer does not have a fever but does show other signs of a cold and/or COVID-19 symptoms (shortness of breath, loss of sense of taste or smell, dry cough, runny nose, sore throat), the Staff Member/Dancer will be kindly asked to return after 14 days.
6. Outside shoes will be disinfected at the door.
7. Bags, phones, water bottles and car keys will be disinfected before being placed in each individual staff bin.
8. Please be patient.

Note: This protocol will be in place until the studio feels the pandemic situation is controlled (even if the County states otherwise).

COVID-19 Pandemic Staff Member/Dancer Protocol – M.I.A.D.F. Consent Form (cont'd)

Staff and Dancer Attire/Studio Requirements

1. Masks – **Staff Members/Dancers must wear a mask when they enter the studio and it must be worn the entire time they are inside studio – no exceptions.** Staff Members/Dancers may wear their own mask from home, or a disposable mask will be provided by studio. Masks with the M.I.A.D.F. logo will be available for purchase – email your order (miadancefactory@gmail.com) and the mask will be provided the next time you enter the studio. Please wash your mask daily at home before returning to studio.

2. Individual Bins - Each dancer will be provided their own plastic bin to place their phone, water bottle, dance shoes and car keys, etc. All items in this bin will be disinfected. This bin will be taken by each dancer to their studio to be placed against the wall, socially distant apart. Plastic bins will be disinfected after each use.
3. Class Time - Classes will run between 45-50 minutes to allow time for check-in, check-out of dancers and to clean studios. Studios will be cleaned and sanitized before and after every class. Barres will be wiped down and the Hip-Hop studio floor will be quickly mopped. Door handles and bathrooms will be wiped throughout class time.
4. Class sizes - Depending on each studio, class sizes will be between 6-18 dancers, in order to keep everyone socially distant.
5. Bathrooms – Bathrooms will be disinfected throughout the day and after each use by a Staff Member/Dancer. Remember the importance of washing hands with soap before leaving the bathroom.
6. Food/Water - Water fountain will be turned off. Our studio does have vending machines for drinks and snacks.
7. Employee Discretion – Staff members should not feel the pressure of ‘missing’ work if they are feeling ill. Your health and well-being are more important to us – please be honest to protect yourself and others.

I understand the above new studio pandemic protocol and the risks of exposure to COVID-19. I agree to comply in order to protect myself and our studio family. I knowingly and willingly consent to conduct business at M.I.A. Dance Factory and that M.I.A.D.F. is not liable should any staff member/vendor contract the COVID-19 virus.
